Minutes of the Annual Parochial Church Meeting (APCM) held on Sunday 22nd May 2022

- Presentation of the Annual report
 - We have established new ways of worshipping and have a new congregation online.
 - We get around 60 adults live online and others who watch later. This has been stable since the autumn.

- The PCC were working on a vision process but this was put on hold during the pandemic.
- We have re-started the children's work. A new team grew out of the online Junior Church. Junior church has been reshaped and that is bearing fruit
- We now need to find a way forward to work with the youth.
- We have more adults now than in 2019 but we still have a lot of rebuilding work to do.
- We need to be flexible and do things differently.
- Discipleship and mission activities are a big part of who we are.
- Andrew said he was indebted for the gracious understanding of the congregation. Some other churches have not seen this.
- Helen Cosstick commented on the Eco church work. David Sebuyira's team have secured the bronze award.
 This initiative is extremely important.
- We have also adopted the Grove as our local mission partner. The Grove
- Andrew said he welcomed questions which is especially important in a time of change. We need to have adult conversations in a Christlike way.
- Yvonne Johnstone thanked the Clergy and Church Leadership team for enabling church to continue and evolve during and post the pandemic.

Presentation of Electoral Roll – 133

Three less than last year – with some people joining us and some leaving.

• Treasurer's report for the year ending 31 December 2021

Chris Cosstick presented a summary of main points of the accounts

- The income for 2021 was up from 2020, and church giving has remained the same. Chris thanked people for maintaining their giving during this difficult time.
- The hall rental is higher than expected due to the vaccine centre. We provided this resource to the community, and we received rent from Remedy Pharmacy.
- Expenses for 2021 are considerably less than 2020. This is primarily due to a reduction in the money we pay to the Common Fund (which allows the diocese for example to pay clergy and support other churches in need). The Diocese agreed for us to reduce our contribution from £85k to £60k for 2021. However, by the end of the year we were able to add a top up payment of £6k.
 - This concession is in place for 2022 but for 2023 the expectation is that we will need to revert to our original payment level.
- The Hall kitchen refurbishment in 2020 cost £14,777
- The PCC sets a budget at the start of the year. We have done well in not overspending in any particular area.
- The overall result for all funds for the year ending December 2021 is a surplus of £13,882 against a deficit of £11,475 the previous year. This improvement is mainly due to the reduced Common Fund payment.
- The general and hall fund combined gives a surplus of £18,351 as against a deficit of £321 last year. The hall income helps us do our church work. This surplus was used in part to top up the reserves fund by £12k. The Charity Commission recommends charities hold a reserve fund to have something to fall back on. We had to draw on it last year and so have topped this up back to £27k.
- We receive £7.5k a year from the Hobbayne Charity for our fabric fund. We used £12.8k last year for repairs to the church stonework. There is now £25k in this fund.
- We also set up a recovery fund of £2k in 2020 which allowed us to improve our technical equipment. It is hoped to spend a similar amount in 2022.
- There is £14k in the hall fund. Work needs to be undertaken on the windows.
- There are some smaller funds totalling £5,529, bringing the total fund balances to £74,153 which is the exact amount in the bank.
- Thanks were expressed to Mervat for her work on the planned giving, including claiming Gift Aid from the HMRC

- Also, Yvonne Johnson, the treasurer before Chris who has been meeting with Chris once a month to input accounts into the computer system.
- Helen White has also kept a watching brief over the finances for the last 12 months.

Appointment of Independent Examiner (auditor)

We appointed Kevin Ogilvie of Charity Bookkeeping and Examination Services 2 years ago and he is willing to carry on. Proposed by Sue Cosstick and seconded by Tim Barnes. All in agreement.

Election of PCC members

Tamsyn Kent and Susan Powrie have come to the end of their second term of three years on the PCC and now need to take a year's break.

There were 4 vacancies on the PCC and 6 candidates This means that an election was necessary.

The result was that John Hennessy, Camille Adams, Frances Scott and Helen White were elected on to the PCC for 3-year terms.
